# Midland College Syllabus Online TECA 1303 Spring Families, Schools and Community (3-0-0)

## **Course Description:**

A study of the child, family, community, and schools. Includes parent education and involvement, family and community lifestyles, child abuse, and current family life issues. Course content is aligned as applicable with State Board for Educator Certification Pedagogy and Professional Responsibilities standards. Requires students to participate in a minimum of 16 hours field experience with children from infancy through age 12 in a variety of settings with varied and diverse populations.

- 3. Examine characteristics of diverse culture and lifestyles

11 Lab Assignments at 50 points each for a total of 550 points. These will be graded on a rubric.

4 tests at 100 points each for a total of 400 points.

All assignments will be graded within 7 days of the due date. If for some reason, there is a delay I will alert you.
