# MIDLAND COLLEGE SYLLABUS SEMESTER AND YEAR HMSY 1337 Introduction to Homeland Security

### **COURSE DESCRIPTION:**

This course is an overview of homeland security, including an evaluation of the progression of homeland security issues throughout Texas and the United States. The roles undertaken and methods used by governmental agencies and individuals to respond to those issues are examined. Upon successful completion of this course the student should be able to list the key events and people that have affected homeland security, outline the specific roles that individuals and governmental agencies play in homeland security, and prepare a summary of programs and methods used to meet the homeland security needs of Texas and the United States.

#### **COURSE GOALS / OBJECTIVES:**

Upon successful completion of this course, the student will be able to:

- identify issues associated with homeland security;
- discuss terrorist acts committed against the United States;
- define terrorism;
- demonstrate a basic understanding of al Qaida and other terrorist organizations;
- identify the problems and issues associated with cyberterrorism and cybersecurity;
- identify various laws passed in response to global terrorism.

# **PARTICIPATION STATEMENT**

Students must dedicate themselves to learning while in college. You should follow the syllabus, read each chapter before it is discussed in class, and use effective study techniques (e.g. note taking, outlining the text, flash cards; study groups) to improve chances for success.
