VNSG 1361 Clinical II (0-0-15)

General Course Information

Course Description

VNSG1361 is a health-related work-based learning experience that enables the student to apply specialized occupational theory, skills, and concepts in the critical care setting. Direct supervision is provided by the clinical professional.

WECM End of Course Outcomes

Provide quality nursing care to patients in the clinical setting demonstrating responsibility, accountability, and competence in accordance with policies and procedures of the practice setting or health care institution. Student will demonstrate the ability to pass required medication administration check-off, and pass dosage calculation exam.

Student Learning Outcomes and Core Competencies

The following course student learning outcomes (SLO's) are based on the Differentiated Essential Competencies (DECs) identified by the Texas Board of Nursing for the nursing roles of Member of the Profession (MOP), Provider of Patient-Centered Care (PPCC), Patient Safety Advocate (PSA), and Member of the Health Care Team (MHCT). Upon Successful completion of the course the student will:

1. Function within the nurse's legal scope of practice to provide quality nursing care to patients in the clinical setting demonstrating responsibility, accountability and competence in accordance with regulation and the policies and procedures of the practice setting or health care institution. (MOP-A)
2. Demonstrate clinical reasoning, understanding, and application of evidence-based policies to provide physical, psychological, ethical, and spiritual care for socially diverse patients. (PPCC-C)
3. Provide safe and caring nursing care to assigned patients with predictable health care needs within a supervised and directed scope of practice. (PPCC-H)
4. Implement measures to promote a safe environment for patients, self and others within the clinical setting. (PSA-B)
5. Communicates, collaborates, and advocate with patients, their families, and the healthcare team to deliver coordinated care to assigned patients. (MHCT-B)
6. Uses appropriate decision making in the clinical setting using appropriate resources and mandatory reporting requirements. (PSA-E)
7. Assist health care teams during local and global health emergencies to promote health and safety, and prevent disease. (MHCT-G)

Course Outline/Schedule

Detailed course outline/schedule provided to the students at the start of class.

Week 1-6: Capstone skills (rechecks), advanced skills, medication administration, dosage calculation, clinical orientation

Week 5-16: Clinical Rotation at assigned hospital unit 0630-1500 (See Skills/Clinical Schedule)

Capstone Rechecks:

Students will be performing check-offs on previously mastered skills from 1st semester. Students will draw at random 4 previously mastered skills to demonstrate from the following:

Insertion of NGT

Enema

Foley (male or female)

Trach Care/Trach Suction

Trach Suction

Wound Care

Students graded per the Capstone Mastered Skills sheet.

Advanced Skills:

Administering Oral Medications

Instilling Eye Medication

Administering Topical Skin Medications

Administering an Intradermal Injection

Administering a Subcutaneous Injection

Administering an Intramuscular Injection

Phlebotomy/obtaining blood sample with Vacutainer

Starting IV

Administering primary/secondary IV fluids

Medication Administration

Students have 3 attempts to pass the medication administration check off. This must be done before student can pass medication during clinical. If student is unable to pass within 3 attempts, it is an automatic "F" in the clinical course, and dismissal from the vocational nursing program. (Please see Vocational Nursing Student Handbook)

Math Competency Exam

Students have 2 attempts to pass the Dosage Calculation Exam with an 85% or higher. This must be done before student can pass medication during clinical. If student is unable to pass with an 85% or higher within 2 attempts, it is an automatic "F" in the clinical course, and dismissal from the vocational nursing program. (Please see Vocational Nursing Student Handbook)

Student Contributions and Class Policies

Student Contributions

1. Students must provide and keep current with certain documentation in order to participate in clinical activities. Students will not be allowed to attend clinical without documentation, and absence will be documented
2. Student is required to be certified in Cardiopulmonary Resuscitation (CPR) before entering the program, and keeping it current throughout the Vocational Nursing program. Health Provider CPR certification must be obtained from the American Heart Association indicating training for adults, children, and infants.
3. Students enrolled in clinical nursing courses must purchase professional liability insurance. Student liability insurance is incorporated in the registration fees.
4. Students must maintain health insurance coverage while enrolled in clinical courses, this must be obtained by the student.
5. Although all these immunizations/immunity are required for entrance into the VN program, students must be current on documentation showing immunizations or immunity to:
 - Tetanus (TD) Tdap
 - Measles, mumps, and rubella (MMR) – 2 doses
 - Varicella
 - Hepatitis B – 3 doses
 - Tuberculosis (TB)
 - Meningitis

Class Policies

1. VNSG1361 meets for an 8-hour clinical rotation twice per week, plus 4 scheduled 8-hour high fidelity Simulations (32 hours total). In order to meet the goals of VNSG1361, the student must attend and participate in all learning activities, and the clinical component associated with the course.
2. In order to progress in the vocational nursing program, the student must pass both the theoretical and clinical components of the course.
3. The student is responsible for knowing and adhering to the Midland College Vocational Nursing Student Handbook. The student must contact the instructor prior to class to report an absence or tardy.
4. No assignment is optional. No late work will be accepted. The grade will be recorded as a zero (0). All work must be original. Please refer to the Student Handbook on policies regarding Cheating/Plagiarism.
5. The instructor will dismiss a student from class for disruptive and inappropriate conduct.
6. All cell phones are to be turned off during clinical. Any use of cell phones during clinical is considered disruptive behavior, and student will be dismissed from class. Watches with internet access are not permitted during exams, quizzes, or review.
7. There is a zero tolerance for academic dishonesty. Penalty for academic dishonesty is an automatic failing grade of "F" in the course and dismissal from the program.
8. Clinical rotations will require student to travel to facility. Each student is expected to provide his/her own transportation and expenses.
9. Students are not allowed to perform skills that haven't been mastered in the skills lab. See Vocational Nursing Student handbook.
10. Faculty/students will not be allowed to leave clinical facility during scheduled clinical hours, unless issue permits that the class as a whole must leave clinical for the day. Faculty must be on site as long as students are there. No leaving during lunch and/or breaks.
11. Students deemed unsafe or incompetent will fail the course and receive a course grade of "F". The behaviors constituting clinical failure include, but are not limited to:
 - *Demonstrates unsafe performance and makes questionable decisions.*
 - *Cannot perform mastered skills in the clinical setting.*
 - *Lacks insight and understanding of own behaviors and behavior of others.*
 - *Needs continuous specific and detailed supervision.*
 - *Has difficulty in adapting to new ideas and roles.*
 - *Fails to submit required written clinical assignments.*
 - *Falsifies clinical hours.*
